## ANTI-SLAVERY AND HUMAN TRAFFICKING POLICY

Modern slavery is a crime and a violation of fundamental human rights. All types of modern slavery have in common the deprivation of a person's liberty by another in order to exploit them for personal or commercial gain. Clevedon Fasteners are committed to acting ethically and with integrity in all of our business dealings and relationships and to ensure modern slavery is not taking place anywhere in our own business, or in any of our supply chains.

We are committed to ensuring there is transparency in our own business and in our approach to tackling modern slavery throughout our business relationships, consistent with the disclosure obligations under the Modern Slavery Act 2015. As part of this process, we are undertaking a review of our supply chain to identify and assess potential risk areas and maintain a register detailing the same.

This policy applies to all persons working for us or on our behalf in any capacity, including employees at all levels, directors, officers, agency workers, seconded workers, interns, agents, contractors, external consultants, third party representatives and business partners

This policy does not form part of any employee's contract of employment and we may amend it at any

time.

The Clevedon management team has overall responsibility for ensuring this policy complies with our legal and ethical obligations, and that all of our people comply with it.

The Human Resources Department has primary and day-to-day responsibility for implementing this policy, but the procurement team provide assistance when reviewing the risk profile of our supply chain to ensure that any procedures implemented are effective in countering modern slavery.

## **COMPLIANCE WITH THE POLICY**

You must ensure that you read, understand and comply with this policy.

The prevention, detection and reporting of modern slavery in any part of our business or supply chains is the responsibility of all those working for us or under our control. You are required to avoid any activity that might lead to, or suggest, a breach of this policy.

Although you should report any concerns regarding modern slavery and/or human trafficking in any parts of our business or supply chains in accordance with our whistle blowing policy, you are also encouraged to discuss a specific matter (or our policy or relevant legislation) with any Director of the Company.
